Item No.4: Any other issue with their permission of the Chair.

i) In the matter of fixation of fees for PG courses run by Ayurved Mahavidyalaya, Nashik.

Read communication dated 5/4/2019 received from Ayurved Mahavidyalaya, Nashik. Heard 1. Dr. S.L. Dasari, Principal, 2. Dr. V.R. Sonambekar, Superintendent/ Professor. This college is conducting UG & PG courses. UG course is aided whereas PG course is unaided. Till the academic year 2018-19 they have been collecting fees from the students prosecuting PG course. It was expected of the college to submit fees proposal for the AY 2019-20. No such proposal has been submitted on or before 31/10/2018 and even till date, to this Authority. Statement of Income and Expenditure, Auditor's report and other relevant documents are not available. Whatever the fees collected till 2018-19 was as per the Government GR dated 4/7/2017. In that, no interference is called for.

As regard fees structure for AY 2019-20, the college is permitted to collect half the adhoc fee declared by this Authority for the AY 2018-19. Vide decision dated 25/4/2018, this Authority fixed Rs. 1,50,000/- as a adhoc fees for PG course in Ayurved. In view of this, the college can collect adhoc fee of Rs. 75,000/- for PG course in Ayurved from the students in AY 2019-20 batch. The college to submit fees proposal for AY 2020-21 within time and without fail.

ii) **In the matter of fixation of Adhoc fees for P.G.D.M.L.T. course run by Sai Care Paramedical Institute, Nashik.**

Read communication dated 31/1/2019 received from Sai Paramedical Institute, Nashik. This is regarding Paramedical course (P.G.D.M.L.T.). The Institute is conducting this course which is unaided.

For exercising jurisdiction by this Authority, the course has to be declared as Professional Course under section 2 (r) of Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015. Till date there is no any notification declaring P.G.D.M.L.T. as Professional Course. Therefore, this Authority has no jurisdiction to entertain fees proposal relating to this course.

Therefore, request of the Institute to approve fee structure of the said course cannot be entertained.
